An 18-year resident of Cherry Hill, Pamela Rosen Lampitt, 44, was elected to the Cherry Hill Township Council in 2003 after serving on the township Zoning Board.

As a councilwoman, Rosen Lampitt is an advocate for quality-of-life issues - - leading the fight to preserve open space in Cherry Hill. Behind the scenes, Rosen Lampitt spearheads efforts to streamline town management and eliminate bureaucratic headaches. She also has led the effort to better coordinate economic development and encourage greater communication among the township's businesses.

In the mid 1970s, Pam was inspired by her mother's selfless dedication to Aid for Cancer Research, a volunteer organization devoted to grants for vital medical research. As a result, Rosen Lampitt is active in the South Jersey Chapter of the City of Hope, a cancer research institution. Rosen Lampitt's personal experience has made affordable and accessible quality healthcare -- with an emphasis on expanding cancer research opportunities in the Garden State -- one of the platforms of her candidacy for Assembly.

Rosen Lampitt was born in Natick, Mass., and graduated from Johnson and Wales College with a degree in Culinary Arts and Management.

Rosen Lampitt has been married to her husband, Charles, for 22 years. Their daughter, Ilene, 18, is a freshman in college, and their son, Andrew, 16, currently is a junior at Cherry Hill High School West. Rosen Lampitt has been active in her children's athletics through the Cherry Hill Girls Soccer Club and at Cherry Hill High School West.

Rosen Lampitt has worked at the University of Pennsylvania for 24 years and currently is the General Manager for Conference Services. She has served on a number of steering committees on the campus, working on the Committee for Manufacturer Responsibility, which ensures university products are manufactured under fair labor standards.
