We have been asked by McCarter & English on behalf of a client of theirs to seek an opinion from the Attorney General that the corporation may make political contributions to New Jersey state candidates.

The question involves consideration of N.J.S.A. 19:34-45 and the extent of its applicability in the circumstances presented. The Commission has no jurisdiction with respect to the question.

The Commission has, however, from time to time sought the opinion of the Attorney General on similar matters, since the Commission has the responsibility of administering certain of the laws respecting political contributions and expenditures, and we request that you consider issuing an opinion in this matter.
