Dear Ms. Massar:

This will confirm facts which I have previously discussed well wou over the telephone, and serve as a request for an advanced ruling the Commission.

- I am currently Chairman of the Middletown Township Democratic Executive Committee, and have held that position since June of 1983.
- I have obtained permission to paint "Florid for Governor" on a Water Tower located adjacent to Route 287 in Edison, M.J. ("The Project")
- I have obtained commitments from several individuals to donate the necessary funds for the Project. My intention is to form a separate independent Committee to which individuals will contribute and which will pay for the Project.
- The above Project has been done without the advice, consent, approval, knowledge or direction of anyone associated with the Florio Campaign.
- Any person who has indicated they will contribute to the Committee. has been told that they cannot discuss the Project with any official of the Florio Campaign, at least prior to completion of the Project.
- The cost to paint "Florio for Governor" on the water tower is approximately \$2,500. It will cost approximately the same amount (\$2,500) to repaint the water tower. My intention is to obtain approximately \$5,000 of contributions. The Committee will spend \$2,500 almost immediately upon receiving a ruling from the Commission. The Committee will continue in existence until shortly after the Election when the water tower will be repainted. The additional \$2,500 will be spent at that time.

- 7. As Chairman of the Democratic Party in Middletown, I have had and anticipete having contact with the Florio Campaign. For example, I recently discussed the possibility of including Jim Florio's name on our local compaign lawn signs. I have not, however, mentioned the Project during any discussion with the Florio Campaign.
- 8. In 1981 I had "Florio for Governor" painted on this same water tower. To the best of my knowledge, then as now, neither Mr. Florio nor anyone associated with his campaign knew about the water tower before it was painted.

Based on the above, I would appreciate the Commission's opinion concerning the following issues:

- Would the expenses associated with the Project be charged against the Florio Campaign. In other words, would the expenses be considered in determining the Campaign's limit or cap on expenditures.
- 2. If it will not be charged against his campaign, are there any prohibitions against notifying him or his campaign about the Project after it has been completed? (i.e. after "Florio for Governor" has been painted on the water tower)
