August 25, 2021

# 1. Open Public Meetings Statement

Chairman Jaso called the meeting to order, and Executive Director Brindle announced that pursuant to the "Open Public Meetings Act," N.J.S.A. 10:4-6 et seq., notice of this special meeting of the Election Law Enforcement Commission could not be announced and distributed with adequate notice for the following reasons:

The Commission believes that it is in the public interest to act expeditiously upon a matter of importance and concern to the public interest regarding the 2021 gubernatorial debates' schedule. The Commission could not have reasonably foreseen the need for this meeting at a time when adequate notice could have been provided. The meeting was announced for August 25, 2021 at 11:00 A.M., via Telephone/GoToWebinar, and was distributed at approximately 10:03 A.M. on August 24, 2021, to the entire State House press corps and was filed with the Secretary of State's Office. It was also posted on the Commission's website. The agenda of the meeting will be limited to discussion of the matter of importance. The Commission believes that it is in the public interest to act expeditiously upon this matter.

In light of the fact that notice for this special meeting was not given 48-hours prior to the meeting, the Commission may suggest that there be a motion and vote to enact a resolution authorizing the holding of this special meeting to establish that a delay for the purpose of providing adequate notice would result in substantial harm to the public interest.

On a motion by Commissioner Simon, seconded by Commissioner Holden, and passed by a vote of 3-0, the Commission resolved to hold the special meeting.

### 2. 2021 General Election Gubernatorial Debates

Chairman Jaso announced that on the table is a question about the timing and schedule of the general election gubernatorial debates for this year. Currently those dates are set for September 28<sup>th</sup>, October 5<sup>th</sup>, being the lieutenant governor debate, and the last gubernatorial debate October 12<sup>th</sup>. The gubernatorial debates are hosted by New Jersey Performing Arts Center and their group and Public Media New Jersey, Inc. and their group. The Murphy campaign is requesting to move up the lieutenant governor's debate and the second gubernatorial debate to September 30<sup>th</sup> and October 5<sup>th</sup>, respectively. He said that there is also a question about television coverage for the lieutenant governor's debate. Chairman Jaso stated that the Murphy campaign by a letter dated August 23<sup>rd</sup>, requested to move up the lieutenant governor and the second gubernatorial debate to within a week of the first gubernatorial debate. The Murphy campaign proposed Tuesday, September 28, for the first gubernatorial debate; Thursday, September 30<sup>th</sup> for the lieutenant governor's debate, and the second gubernatorial debate on Tuesday, October 5<sup>th</sup>. The request is for the purpose of having more people view the debates prior to early voting and vote by mail.

## 5. 2021 General Election Gubernatorial Debates

The Commission, by a vote of 3-0, rejected and denied the Murphy campaign's request and concurred to keep the existing sponsorship of the debates and keep the existing schedule of the debates, the first gubernatorial debate being September 28th, the lieutenant governor's debate being October 5th, and the second gubernatorial debate being October 12th. The Commission pointed out there is nothing preventing the candidates from holding earlier debates not overseen by ELEC. Commission members agreed to leave as it is for the coverage of the lieutenant governor's debate.
