PUBLIC SESSION MINUTES

September 19, 2023

Chairman Thomas H. Prol, Commissioner Ryan Peters, Commissioner Norma R. Evans, Commissioner Jon-Henry Barr, Legal Counsel Edwin R. Matthews, Executive Director Jeffrey Brindle, Deputy Director Joseph Donohue, Deputy Legal Director Amanda Haines, Compliance Director Stephanie Olivo, Review and Investigation Director Shreve Marshall, and Legal Administrator of Review and Investigation Theresa Lelinski were present. Chairman Prol convened the meeting at 11:00 a.m. in Trenton and explained meeting procedures.

1. Open Public Meetings Statement

Chairman Prol called the meeting to order and announced that pursuant to the "Open Public Meetings Act," N.J.S.A. 10:4-6 et seq., adequate notice of the meeting of the Commission had been filed with the Secretary of State's Office and distributed to the entire State House Press Corps. It was also posted on the Commission's website.

4. Executive Director's Report

The Executive Director complimented Deputy Director Donohue for his work on the Big Six committees and the county party committees press releases.

The Executive Director stated that the Big Six committees for the first six months of the year raised \$3.6 million and spent \$2.2 million. He said that compared to 2022, they raised \$2.2 million and spent \$1.7 million. There was an overall 64 percent increase in fundraising by the Big Six committees and 29 percent increase in spending, according to the Executive Director.

He said that the county party committees also increased their activity as well. In 2023 \$4 million was raised by the county party committees and \$3.5 million spent, compared to 2022 where \$3 million was raised and \$3.2 million was spent. Overall in 2023 the county party committees raised 33 percent more than they did the previous year and 9 percent more spent the previous year.

Executive Director Brindle said that Finance and Administration Director Chris Mistichelli has begun the search process for the executive director position and legal director position.
