## ADVISORY

The attached is an alphabetical listing of political action committees (PACs) on file with the New Jersey Election Law Enforcement Commission commencing with the 1981 general election. The information contained in this list has been accumulated by the Commission from the most recent filing received from each PAC.

As of this listing 39 PACs have indicated to the Commission, by filing a Designation of Campaign Treasurer and Depository form (D-1), that they will be participating in the 1983 general election. It may be assumed, however, that a majority of the PACs who have not advised the Commission of the designation of depository of treasurer will be active in the 1983 general election.

The last comprehensive alphabetical listing of PACs prepared by the Commission was following the 1981 general election. Since then, an additional 32 PACs have filed reports with the Commission.

The listing released today reflects information filed as of September 22, 1983. The list will be updated periodically to reflect any new PAC filers or changes in treasurer or telephone number of the PAC.
