Attached is a summary of receipts and disbursements from selected Legislative races which has been prepared by the Election Law Enforcement Commission. The accompanying summaries have been prepared by aggregating information reported by each candidate, supporting campaign committees, and statewide campaign efforts of the candidates' state political party. The information has also been prepared to prevent duplicative consideration of receipts or disbursements among the candidates or the statewide committees.

The information contained in the attached summaries is based upon the 25-day pre-election reports filed by the candidates and supporting committees. These reports are required to reflect information through October 13, 1983.

Reported disbursements include actual disbursements as well as outstanding obligations, not including outstanding loans.

Information reported under the heading of receipts includes: contributions; transfers from other committees; allocation of expenditures by the state political party or legislative campaign committee, i.e. Republican campaign contributions, (S.C. Allocations), and loans. Allocations from committees other than the state political party committee are included in "contributions".

Information reported under the heading "slate totals" reflects an aggregation of the financial activity of the three legislative candidates running within the district.

Summaries have been prepared with respect to district 1, 2, 10, 13, 14, 18, 21, 30, 34, 36, 38, 39.
