IMMEDIATELY OCTOBER 31, 1984

The Election Law Enforcement Commission today released a revised list of names of candidates in the general election who have not filed any required disclosure reports with the Commission as of noon yesterday, October 30, 1984. The list contains 8 county-wide candidates and 53 candidates for local municipal office.

These candidates were required to file either detailed campaign reports 29 and 11 days prior to the election (October 9 and October 26) or a Sworn Statement indicating that expenditures on their behalf in their campaign would not exceed \$2,000. This form was required to be filed on or before the 29th day prior to the election (October 9, 1984).

Timely filing may be accomplished by submitting an original and two copies of the report to the county clerk's office before noon on the filing due date. After that time, filing is only accomplished by submitting the reports directly to the Commission's office in Trenton. Reports filed at the county clerk's office after noon will not be considered filed until such time that they arrive at the Commission's office in Trenton.

The publication of this list is part of revised Commission procedures, begun with the 1978 primary election, designed to foster compliance, enhance disclosure and make enforcement more effective. The list is being revised due to a typographical error which listed a candidate's municipality incorrectly.

The candidates whose names appear on the attached list will be the subject of Commission complaints and hearings for non-filing unless there are extraordinary mitigating circumstances responsible for the failure to file. They, thus, will be subject to possible fines of up to \$1,000 if found in violation. Additionally, of course, the candidates will be required to file the appropriate reports or Candidate - Sworn Statement.

Other candidates in the 1984 general election who have already filed, but filed late, or have substantive problems in their reports, also will be subject to possible reprimand or fines through the Commission hearing and complaint process.

There are in excess of 1,800 candidates for county and municipal office in the 1984 general election.
