To date, the Commission has certified a total of \$443,287.42 in public matching funds to former U. S. Attorney Del Tufo (D), \$600,965.44 in public matching funds to Newark Mayor Gibson (D), \$643,572.40, the maximum, in public matching funds to Governor Kean (R), \$643,572.40, the maximum, in public matching funds to State Senator Russo (D), \$643,572.40, the maximum, in public matching funds to Essex County Executive Peter Shapiro (D), and \$643,572.40, the maximum, in public matching funds to former State Senator Wiley (D). Including Monday's certification, the Commission has certified a total of \$3,618,542.46 as follows:

On Monday, the Commission received applications for public matching funds from the candidates. The Commission received applications for the current submission period from Mr. Del Tufo, Mayor Gibson, and Mr. Wiley. The candidates reported contributions (less refunds) for this submission period as follows:

Monday marked the sixteenth date on which candidates could make application for public matching funds. To date a combined total of \$2,252,558.08 in contributions raised (less refunds) has been indicated by candidates making application for public matching funds

The New Jersey public financing program provides that each dollar of a contribution be matched with two dollars of public funds after a candidate has raised and spent a minimum of \$50,000.00 in contributions of \$800.00 or less. The maximum amount that a qualified candidate can receive in public matching funds for the 1985 gubernatorial primary is \$643,572.40.

The submissions received Monday will be reviewed and the Commission will certify to the State Treasurer the remaining reviewed amount each candidate is eligible to receive for the sixteenth submission period at its meeting on Wednesday, June 12, 1985.
