The Election Law Enforcement Commission today released a list of names of candidates and joint campaign committees in the general election who have not filed any required disclosure reports with the Commission as of noon October 31, 1985. The list contains 1 gubernatorial candidate, 5 legislative candidates, 1 legislative committee, 6 countywide candidates, 3 countywide committees, 92 municipal candidates and 24 municipal campaign committees.

Candidates and committees were required to file either detailed campaign reports 29 and 11 days respectively prior to the election (October 7 and October 25) or a sworn statement indicating that expenditures made on their behalf would not exceed \$2,000 or \$4,000 respectively. The sworn statement was required to be filed on or before the 29th day prior to the election (October 7, 1985).

Timely filing may be accomplished by submitting an original and two copies of the report to the county clerk's office before noon on the filing due date. After that time, filing is only accomplished by submitting the reports directly to the Commission's office in Trenton. Reports filed at the county clerk's office after noon will not be considered filed until such time that they arrive at the Commission's office in Trenton.

The publication of this list is part of the revised Commission procedures, which began with the 1978 primary election, designed to foster compliance, enhance disclosure and make enforcement more effective.

The candidates and committees whose names appear on the attached list will be the subject of Commission complaints and hearings for non-filing unless there are extraordinary mitigating circumstances responsible for the failure to file. They, thus, will be subject to possible fines of up to \$1,000 if found in violation. Additionally, of course, the candidates and committees will be required to file the appropriate reports or a sworn statement.

Other candidates and committees in the 1985 general election who have already filed, but filed late, or have substantive problems in their reports, will also be subject to possible reprimand or fines through the Commission hearing and complaint process.

There are in excess of 2,000 candidates for State, county and municipal office in the 1985 general election.
