Frederick M. Herrmann, Executive Director of the New Jersey Election Law Enforcement Commission, announced today that during the 29-day preelection filing period that covers activity up to a month before the ection, candidates for the Assembly reported raising \$4,698,553 and stinding \$2,872,296.

According to Herrmann, these rough preliminary figures indicate that since 1985, the last time a Gubernatorial and an Assembly race occurred together, receipts have risen by 64 percent and expenditures by 68 percent. During the same period in 1985, receipts totaled \$2,866,961 and spending amounted to \$1,711,247.

In 1987, a less comparable year because both the State Senate and Assembly were up for election, candidates for the General Assembly reported raising \$3,830,953 and spending \$1,926,367 during the 29-day preelection filing period. Thus, receipts increased by 34 percent between 1985 and 1987 and expenditures increased by 13 percent. Between 1987 and 1989, Assembly fundraising increased by 23 percent and expenditures rose by 49 percent.

"In the 1989 general election, Democratic Assembly candidates have thus far reported receipts amounting to \$2,763,569 and expenditures of \$1,766,549," said Herrmann. "Republicans, on the other hand, reported raising \$1,933,984 and spending \$1,104,908."

The preliminary figures indicate that Democratic candidates have therefore outdistanced Republican candidates in fundraising by 43 percent and in spending by 60 percent. In 1985, Republicans outraised Democrats by 13 percent, \$1,518,696 to \$1,346,852, and outspent them by 15 percent, \$915,323 to \$795,736. During 1987, Republicans raised 11 percent more than Democrats, \$2,011,831 to \$1,816,435. At the same time, the Democrats spent 6 percent more than the Republicans, \$989,134 to \$936,313.

Esince 1985, Democratic Assembly candidates increased their receipts by 105 percent, from \$1,346,852 to \$2,763,569 and Republican candidates by 27 percent, from \$1,518,696 to \$1,933,984. Democratic expenditures increased over this four-year period by 122 percent, \$795,736 to \$1,766,549, and Republican expenditures rose by 21 percent, \$915,323 to \$1,104,908.

According to Herrmann, between 1985 and 1987, Democratic receipts rose by 35 percent, \$1,346,852 to \$1,816,435 and their expenditures increased by 24 percent, \$795,736 to \$989,134. He said that Republicans increased their fundraising by 32 percent, \$1,518,696 to \$2,011,831, and

increased their spending by 2 percent, \$915,323 to \$936,313.

"From 1987 to 1989," added Herrmann, "Assembly Democratic candidates intensified their fundraising by 52 percent, \$1,816,435 to \$2,763,569, and their expenditures by 79 percent, \$989,134 to \$1,766,549. Republican receipts decreased by 4 percent, from \$2,011,831 to \$1,933,984. Expenditures, however, increased by 18 percent, from \$936,313 to \$1,104,908."

The rough preliminary statistics also reveal that incumbents strongly dominated the fundraising activity of Assembly candidates.

Herrmann said that incumbents have raised \$3,077,162, or 65 percent of the funds and spent \$1,762,640, or 61 percent of the expenditures. The 1989 statistics show that Assembly challengers raised \$1,621,391 and made expenditures of \$1,109,656.

"The dominance of incumbents in raising money has continued," stated Herrmann. "In 1985, Assembly incumbents raised 68 percent of the funds and spent 61 percent of them and in 1987 they raised 58 percent of the campaign money and spent 52 percent of it."

ELEC data reveals that during the four-year period since 1985, Assembly incumbents increased their fundraising by 57 percent, from

\$1,955,738 to \$3,077,162. During this period, they also increased their spending by 70 percent, from \$1,035,696 to \$1,762,640. Challengers increased their receipts by 78 percent, from \$911,224 to \$1,621,391, and increased their spending by 64 percent, \$675,551 to \$1,109,656.

Between 1985 and 1987, incumbents increased their fundraising by 14 percent, from \$1,955,738 to \$2,235,654. Their expenditures decreased by 2 percent, \$1,035,696 to \$1,010,297. Challengers increased fundraising activity during this earlier two-year period by 75 percent, \$911,224 to \$1,595,299 and increased their spending by 36 percent, \$675,551 to \$916,070.

During the period 1987 to 1989, incumbents receipts rose by 38 percent, \$2,235,654 to \$3,077,162 and their spending by 74 percent, \$1,010,297 to \$1,762,640. Challengers increased their receipts by 2 percent, from \$1,595,299 to \$1,621,391, and increased their expenditures by 21 percent, from \$916,070 to \$1,109,656.

In sum, campaign fundraising and spending continue to explode. A further telling indicator of this trend is that the top ranked fundraiser and spender in 1989 outraised and outspent their 1985 counterparts by more than two times. According to Herrmann, "the Commission hopes that its analysis will highlight for the electorate the critical need to reform New Jersey's campaign financing system for legislative elections with controls on fundraising and spending."

This press release is a compilation of figures reported on the 29-day preelection reports of candidates and committees. Only those reports received as of 5:00~p.m. on October 11, 1989 were included; those reports received after that date were not considered.

Figures are based upon data taken directly from each report, prior to any mathematical or technical review. Therefore, the figures may change at a later date after the review process is completed.

Also, please be reminded that candidates and committees may transfer funds between each other. Although these transfers are counted in ELEC's statistics as receipts and expenditures, they are not transactions which create new funds. Nevertheless, ELEC's figures create a useful indicator of overall fundraising and spending in the General 1989 election.
