According to preliminary figures compiled by the Election Law Enforcement Commission, candidates for the Assembly have reported raising \$7,191,440 and spending \$5,005,234 as of the 11-day preelection filing period.

Frederick M. Herrmann, the Commission's Executive Director, noting that this Assembly election may well be the most expensive in history, reported that since 1985 receipts have increased by 52 percent and expenditures by 48 percent. During the same period prior to the 1985 election, the last time a Gubernatorial and an Assembly race occurred together, receipts totaled \$4,726,399 and expenditures \$3,374,029.

Herrmann said that in 1987, when both the State Senate and Assembly were up for election, 11-day Assembly receipts totaled \$5,601,243 while spending amounted to \$3,483,538. Receipts, therefore, rose by 19 percent between 1985 and 1987, and expenditures by 3 percent. Between 1987 and 1989, Assembly fundraising increased by 28 percent and spending by 44 percent.

"These preliminary figures dramatically point to the need to reform the campaign finance laws in a way that will place controls on overall financial activity by candidates," Herrmann said, "what New Jersey is experiencing in its legislative campaigns is a fundraising arms race, a development that may well lead to further voter disenchantment with the electoral process."

The ELEC figures show that Democratic candidates have raised 39 percent more money than Republican candidates and outspent them by 43 percent. This year Democratic Assembly candidates reported raising \$4,174,999 and spending \$2,942,164 compared with Republican receipts of \$3,012,666 and expenditures of \$2,059,300.

In 1985 Republicans reported raising 33 percent more money than Democrats, \$2,693,020 to \$2,026,565, and spending 28 percent more, \$1,891,854 to \$1,478,368. During the same period in 1987, Republicans and Democrats raised approximately the same amount, \$2,794,406 to \$2,788,918, and also spent approximately the same amount, \$1,758,043 to \$1,724,277.

Over the four-year period 1985-1989, Democratic Assembly candidates increased their receipts by 106 percent, from \$2,026,565 to \$4,174,999 and increased their expenditures by 99 percent, from \$1,478,368 to \$2,942,164. Republican candidates increased their receipts by 12 percent \$2,693,020 to \$3,012,666, and increased spending by 9 percent, \$1,891,854 to \$2,059,300.

Herrmann said that between 1985 and 1987, 11-day preelection reports showed Democratic receipts rising by 38 percent \$2,026,565 to \$2,788,918, and their expenditures by 17 percent, \$1,478,368 to \$1,724,277. Republicans, during that period, increased their fundraising by 4 percent, \$2,693,020 to \$2,794,406. Their spending, however, decreased by 7 percent, \$1,891,854 to \$1,758,043.

Herrmann added that over the last two years, 1987-1989, Assembly Democratic candidates increased their fundraising by 50 percent, \$2,788,918 to \$4,174,999, and their spending by 71 percent, \$1,724,277 to \$2,942,164. Republican receipts increased by 8 percent, \$2,794,406 to \$3,012,666, and their expenditures increased by 17 percent, \$1,758,043 to \$2,059,300.

In 1987, the 11-day filing period also revealed that incumbents continued to dominate the fundraising race.

This year incumbents so far have raised \$4,642,784, or 65 percent of the funds, and have spent \$3,133,081, or 63 percent of the expenditures. Assembly challengers, on the other hand, have thus far raised \$2,548,656 and spent \$1,872,153.

During the comparable period in 1985, Assembly incumbents raised 63 percent of the funds and spent 59 percent of them. In 1987, incumbents raised 54 percent of the funds and spent 50 percent of them.

"These facts tell the story," said Herrmann. "The dominance of incumbents in raising and spending money, which is the mother's milk of modern campaigns for the legislature, clearly demonstrates the need for reforming campaign finance laws. It is important for there to be a level playing field between incumbents and challengers and controls on fundraising and spending will help to bring that about."

The ELEC statistics show that from 1985 to 1989, Assembly incumbents increased their receipts by 55 percent, from \$2,989,752 to \$4,642,784. Their expenditures also increased by 57 percent, from \$1,999,749 to \$3,133,081. Challengers increased their receipts by 47 percent, from \$1,736,647 to \$2,548,656, and their spending by 36 percent, \$1,374,280 to \$1,872,153.

Between 1985 and 1987, receipts by incumbents increased by 2 percent, from \$2,989,752 to \$3,044,587. Incumbent expenditures decreased by 14 percent, \$1,999,749 to \$1,726,369. Challengers increased their receipts by 47 percent during this two-year period, \$1,736,647 to \$2,556,656, and their expenditures by 28 percent, \$1,374,280 to \$1,757,169.

The two-year period 1987-1989 witnessed incumbent receipts rising by 52 percent, \$3,044,587 to \$4,642,784 and their expenditures by 81 percent, from \$1,726,369 to \$3,133,081. Challenger receipts remained about the same, \$2,556,656 in 1987 and \$2,548,656 in 1989; whereas, their expenditures increased by 7 percent, \$1,757,169 to \$1,872,153.

This press release is a compilation of figures reported on the 11-day preelection reports of candidates and committees. Only those reports received as of 5:00 p.m. on October 27, 1989 were included; those reports received after that date were not considered.

Figures are based upon data taken directly from each report, prior to any mathematical or technical review. Therefore, the figures may change at a later date after the review process is completed.

Also, please be reminded that candidates and committees may transfer funds between each other. Although these transfers are counted in ELEC's statistics as receipts and expenditures, they are not transactions which create new funds. Nevertheless, ELEC's figures create a useful indicator of overall fundraising and spending in the General 1989 election.
