PRESS ADVISORY

As of the third quarter the State parties and Legislative Leadership Committees have raised \$8.1 million and spent \$5 million, according to Jeff Brindle, Executive Director of the New Jersey Election Law Enforcement Commission.

The October 15 reports indicate that financial activity by the so-called "big six" committees have declined dramatically from four years ago, when there was a gubernatorial and Assembly contest.

Receipts by the "big six" decreased by 44 percent since 2005 while spending declined by 43 percent. Fundraising totaled \$14.5 million four years ago while spending amounted to \$8.6 million.

"We are witnessing the same pattern as displayed in the gubernatorial and Assembly contests," said Brindle. "The economy and the Pay-to-Play laws, which affect the big six committees, appear to be impacting financial activity."

"This reverses a trend of increased financial activity that has been apparent over the last two decades," said Brindle.

Brindle said that the Republican State Committee reported raising \$437,602 and spending \$289,221 compared with the Democratic State Committee, which has raised \$3.2 million and spent \$2.8 million thus far in 2009.

The four Legislative Leadership Committees have reported the following financial activity for 2009.

Brindle added that the State committees and Legislative Leadership Committees are required to report their financial activity to the Commission on a quarterly basis.

"As of this juncture," said Brindle, "the three Democratic committees reported \$2.1 million still remaining while the three Republican committees reported cash-on-hand amounting to \$.9 million.
