Legislative candidates vying in three legislative districts with special elections this November have reported raising \$2.1 million and spending \$1.4 million.

Special elections are being held in the 5th, 14th and 31st Districts. According to the 11-day reports filed with the New Jersey Election Law Enforcement Commission (ELEC), the campaign in the 14th district, which traditionally has been viewed as a "swing district" because control has alternated between the two major parties in recent years, is the most heavily contested.

Jeff Brindle, ELEC's Executive Director, pointed out that "in the 14th District Senate contest, candidates already have raised and spent more than in 2007, when the District was included in the pilot Clean Elections Program." The Clean Elections Program offered public funds to legislative candidates who agreed to limit their spending.

Fundraising is up 23 percent compared to 2007, while spending is up 59 percent, Brindle noted.

"The fact that the candidates have already spent most of their funds points to the intensity of the campaign. This is a big race for both parties," Brindle said. "The numbers also show that the pilot Clean Elections Program, which has been discontinued, did help hold down spending in the district."

In addition to the special legislative contests, an election is being held for the County Executive's seat in Bergen County, the state's most populous county.

At this point in his reelection bid four years ago, McNerney held nearly a 9-1 fundraising edge over Republican opponent Todd Caliguire- \$625,026 to \$68,322. During McNerney's first election in 2002, the two parties combined spent \$5.5 million, making it one of the most expensive local elections in state history.

Elections also are being held throughout the State for county and municipal offices.

Brindle said that 11-day reports show that candidates for those offices have raised \$11.5 million and spent \$6.6 million.

"While the economic downturn and tighter contribution limitations for state contractors has curtailed political donations in state races, local races continue to attract considerable campaign cash," said Brindle.

The 11-day pre-election reports further show that county candidates have raised \$7 million and spent \$4.2 million. Municipal candidates have raised \$4.6 million and spent \$2.4 million.
