PRESS ADVISORY

Candidates in three legislative districts that held special elections this November reported raising and spending \$2.6 million.

Special elections took place in the 5th, 14th and 31st districts. According to 20-day post-election reports filed with the New Jersey Election Law Enforcement Commission, the contest for State Senate in the 14th District was the most competitive. Assemblywoman Linda Greenstein (D-Mercer) defeated incumbent Sen. Tom Goodwin (R-Mercer) in the race. They raised and spent a combined \$1.7 million.

In addition to the three special legislative elections, the campaign for the County Executive's seat in Bergen County, the state's most populous county, drew significant funding. In a race won by challenger and County Clerk Kathleen Donovan, the two candidates combined raised and spent \$1.5 million.

Elections also were held throughout the State for county and municipal offices. Jeff Brindle, Executive Director of the New Jersey Election Law Enforcement Commission, said that the 20-day post-election reports show that candidates for those offices raised \$16.5 million and spent \$13.9 million. County candidates raised \$10 million and spent \$8.4 million, while municipal candidates raised \$6.5 million and spent \$5.5 million.

A comparison of fundraising totals for county and municipal candidates in 2010 with totals from four years ago shows that receipts are down about 16 percent and spending is down 20 percent.

"This may show the impact of the recession combined with new restrictions on donations by public contractors that took effect since 2005," Brindle said.

"However, it also seems to show that local candidates have not been hit as hard as statewide candidates. Fundraising by the so-called "Big Six" committees- the two state parties and four legislative leadership committees- was down 36 percent in January compared to four years earlier. Spending was down 34 percent," said Brindle.

Brindle said the difference may be explained in part by the fact that contribution limits on local contractors in many municipalities and counties are looser than tight restrictions imposed on state contractors.

He said one of the top legislative recommendations of the bi-partisan Commission is to adopt a single statewide law to regulate so-called "pay-to-play" donations by contractors instead of allowing individual municipalities and counties adopt local laws that often are less restrictive than the state law.

The charts below show financial activity throughout the 21 counties ranked by receipts. Candidates in Bergen County, the state's most populous county and scene of the high-profile County Executive's race, raised and spent the most by a large margin.
